

Information on the candidate for the position of the Auditor of Rosneft

For the purposes of mandatory annual audit of the 2011 financial (accounting) statements of Rosneft and its subsidiaries prepared in accordance with the Russian Accounting Standards (RAS), the Company held a closed tender for selection of the Sole Auditor for Rosneft and its subsidiaries for review of 2011 accounting statements. Invitations to participants were sent by the Procurement Department on February 3, 2011.

The tender subcommittee for selection of non-production-related service providers considered the bids in accordance with the requirements of Rosneft Standard on 'Organization of tender activities for procurement of goods, works and services No. П2-08 СЦ-001 ЮЛ-001', evaluated and compared the bids (financial offers) against the main criterion of the tender (minimum cost of audit services), and suggested that the Closed Joint Stock Company 'Audit & Consulting Group - Business Systems Development' (hereinafter referred to as CJSC ACG RBS) shall be approved as the Auditor of Rosneft.

CJSC ACG RBS performed the audit of RAS accounting statements of Rosneft and its subsidiaries for 2007, 2008 and 2010.

CJSC ACG RBS has been operating at the audit and consulting services market since July 2001.
